



This application is being filed solely as a result of the Nevada Supreme Court's decision in Great Basin Water Network, et al., v. State Engineer, 126 Nev. Adv. Opn. 2, January 28, 2010. Applicant currently holds Application 39634, which was filed with the State Engineer's Office on November 13, 1979. This instant Application is NOT to be construed as a withdrawal of Application 39634. Applicant requests that the date of filing of this application relate back to that of 39634. It should be noted that there are some differences between this Application and Application 39634 to account for current operations, but the source of water, basin and requested water duty and diversion rates are the same. The maps already filed with the Division of Water Resources for 39634 are the correct maps for this application. Application 39634 was filed in conjunction with 5 other applications (39612, 39613, and 39632-39635) for a total yearly draw of 26,063 acre feet for power generation.
