#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 28837, Certificate 8703; Permit 28838, Certificate 8704; Permits 81109, 81110, 81111, 81113 through 81117 and Claims of Vested Rights V04816, V04819, V04821, V04822, V04468, V04469, and V04470 shall not exceed 23.52 acre-feet annually, or sufficient to water 1000 head of cattle and 50 head of horses.

This permit is subject to the condition that the permittee must ensure that wildlife which has customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.013 cubic feet per second or 8.96 acre-feet annually, sufficient to water 400 head of cattle.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

July 27 2013

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:




13. Miscellaneous remarks:
