This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 58010, Certificate 15376, is issued subject to the terms and conditions imposed in said Permit 58010, Certificate 15376 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permit 67307, Certificate 18739; Permits 68337, 68338, 68792, 68793, Certificate 18740; Permit 68794, Certificate 18741; Permit 68795, Certificate 18742; Permit 68796, Certificate 18743; Permit 68797, Certificate 18744; Permits 71076, 71077, 71078, 71079, 71950, 72264, 77409, 77410, 77411, 77412, 77413, 77414, 81263, 81391, and 81392 shall not exceed 681.76 acre-feet annually. Permits 68337 and 68338 are Sierra Canyon Creek infiltration wells; Permit 68792 can only be pumped when there is no surface water from 68337 and 68338.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued with the understanding that one new residential parcel for a single family dwelling is being created by the dedication of this water right. This permit is limited to the service of one parcel, created from Assessor's Parcel Number 1419-34-002-003. This water cannot be utilized for any new development.

The point of diversion and place of use are as described on the submitted application to support this permit.

A total of 0.703 acre-feet annually is abrogated from the base right. However, pursuant to NRS 533.3703 **only 0.527 acre-feet (the net consumptive use amount) at 0.005 cubic feet per second can be diverted annually. Additional duty up to the total may be granted if it can be shown that this additional duty will not cause the consumptive use amount to be exceeded.**



This application 58010, along with separate applications for 58008 and 58009, is being filed to strip (3) supplemental rights for a total of 1.12 acre-feet. The proposed point of diversion is also known as "Walley's Hot Springs Well #2" and is shown on the map on file with Nevada DWR under Permit 48320.
