This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of a portion of the waters of the Newlands Reclamation Project rights in the Truckee and Carson River final decrees and a portion of Permit 49122, all of Permit 67669 and a portion of Permit 71108, Certificate 17788 which changed the place of use of a portion the Newlands Reclamation Project rights in the Truckee and Carson River final decrees, is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This Permit is issued under the provisions of NRS 533.040 Paragraph 4 and is limited to the irrigation of 99.52 acres within the proposed place of use

The point of diversion and place of use are as described on the submitted application to support this permit.


