APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

The source of water appropriated under this permit is strictly limited to effluent produced by commercial use of water already appropriated. This effluent permit is issued subject to all existing rights on the source. It is understood that the water right herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to a beneficial use. All effluent appropriated under this permit must be measured through a totalizing meter placed at a location which will accurately record the amount of this effluent utilized for irrigation within the permitted place of use. Monthly records of effluent used shall be submitted to the State Engineer on an annual basis by February 15 of each year. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not guarantee the continuous use or availability of water since the source is effluent.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 81744, 81745 and 81746 shall not exceed 1,120 acre feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 2.23 cubic feet per second or 1,120 acre-feet annually.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

December 29 2015

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

December 29 2018

Map in support of proof of beneficial use shall be filed on or before:




Ponderosa Dairy uses a portion of the water pumped under its commercial permits to clean the milking parlors and equipment. This effluent (green water) is then transferred to storage lagoons and land-applied to fields on the property regulated under NDEP Discharge Permit NV0023027. This application seeks to permit the barn 2 effluent for irrigation on all lands within the dairy.

13. Miscellaneous remarks:

This and the two accompanying effluent applications seek to permit the lagoons associated with the three barns as POD. All three effluent permits are intended to be supplemental to each other for a combined total of 1120 afa effluent. No additional groundwater will be diverted under these applications.
