APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion, manner and place of use of a portion of the waters of an underground source as heretofore granted under Permit 12442, Certificate 3831 is issued subject to the terms and conditions imposed in said Permit 12442, Certificate 3831 and with the understanding that no other rights on the source will be affected by the change proposed herein. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. This source is located within an area designated by the State Engineer pursuant to NRS 534.030.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire one year from the date of approval at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit will allow the permittee to dewater the pit area. It is understood that any water obtained as a result of this dewatering operation shall be used first by the permittee for mining, milling, heap leaching, drilling, road watering, and other related mining and milling uses.

Any water pumped and not used for mining and milling purposes shall be infiltrated back to the Big Smoky Valley Groundwater Basin, Northern Part (137B). The permittee shall discharge water in a manner to achieve maximum conservation of the water resource.

The total combined duty of water for consumptive purposes under Permit 536, Certificate 16645; Permit 1077, Certificate 267; Permit 2908, Certificate 353; Permit 3898, Certificate 2347; Permit 12442, Certificate 3831; Permit 12445, Certificate 3832; Permit 12768, Certificate 3751; Permit 14119, Certificate 4889; Permit 26650, Certificate 13904; Permit 26652, Certificate 13905; Permits 44297, 44299, 44300, Certificate 13174; Permits 50971, 51577, Certificate 13185; Permit 51578, Certificate 13186; Permits 53365, 55498, 55500 through 55503, 59217, 59218, 60874 through 60876, 70169 through 70185, 76598 through 76602 and Temporary Permits 81255T, 81256T, 81273T, 81411T, 81420T, 81434T, 81435T, 81575T, 81576T, 81631T through 81633T, 81800T through 81807T, 81984T and 82002T through 82007T will not exceed 13,910 acre-feet annually.

Monthly records shall be kept of the following and reported within 15 days after the end of each quarter:

- A. The total volume of water pumped from each diversion in acre-feet.
- B. The maximum flow rate from each diversion in cubic feet per second.
- C. The pumping water level from each well in feet above mean sea level.
- D. The volume of water consumptively used for mining and milling in acre-feet.
- E. The amount of water diverted to the infiltration sites in acre-feet.
- F. The amount of water diverted to other consumptive uses, if any, in acre-feet.
- G. The amount of water lost through evaporation or other system losses project wide.
- H. The status and flow rates of various surface water sources in the area that may be impacted by the dewatering.

The State Engineer retains the right to require additional monitoring. The permittee, on a schedule acceptable to the State Engineer, shall prepare and present an update on the activities of the mine and the monitoring on a periodic basis, but not less than once per year.

The State retains the right to regulate pumping from the dewatering project and/or any other groundwater withdrawals herein authorized to protect the public interest and to protect existing rights.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.5 cubic feet per second or 361.98 acre-feet annually.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:



Drill and complete a 12 inch dewatering well to a total depth of 1,020 feet, screened from 560-1000 ft. with louvered screen. Gravel packed from 1,040 to 540 feet and the completed to the surface with an approved sanitary seal. The well will be fitted with a three phase submersible pump to lift water to and through the existing water delivery lines.

13. Estimated time required to construct works 3 weeks

This well will serve to dewater the mining pit and to ensure highwall stability. The water developed will be co-mingled with other water rights held by the applicant and will be primarily utilized in the mining and milling processes, including associated reclamation activities.

The following description is provided for Item 8: Existing Place of Use exactly as appears on Certificate 3831. The length of the description precludes placement on the application form.

8. Existing Place of Use: Water is pumped from 307 feet of cased well. (20" perforated casing from 210' to 266', and 12" perforated casing from 266' to 307') in a southwesterly direction through a 6" pipe about 23.3' to what is know as the Jett pipeline (15" O.D.) where it is comingled with waters from the following sources: Applications 2908 and 12445, thence by said Jett pipeline water is conveyed 14,991' in a SE direction to the SW ¼ SW ¼ Sec. 19, T. 10 N., R. 44 E. At this point the water is distributed approximately as follows: ¾ goes to a gravel washing plant located in the same legal subdivision through a 15" steel pipeline about 400' long, the remaining ¼ of the water is distributed about equally between domestic and mining operations. Water to mining operations is diverted at a point about 15,591' in a SE direction from Smith or "B" Well through a 4", 4200' steel pipeline to the mining area located in SW ¼ SW ¼ Sec. 19, T.10 N., R. 44 E. Domestic water is diverted at a point 17,990' in a SE direction from Smith or "B" Well by means of a 2500' of 4" pipeline, 4600' of 2" pipeline, and 4400' of 1" pipeline to 14 family dwellings and 1 general office building. These buildings are located in the NE ¼ and NW ¼ Sec. 30 and SE ¼ and SW ¼ Sec. 19, T. 10 N., R. 44 E., M.D.B.&M.
