

This appropriation seeks to replace the vested water rights existing on the property from springs and seeps that were used historically as a ranch within the place of use. Wells will be drilled to convey the water within the place of use for crop production, primarily for the production of alfalfa and other hay crops. The appropriation is sought to replace the historical use that occurred on or before 1858

13. Miscellaneous remarks:

This application is being filed to mitigate impacts to existing vested rights on Willow Field. This application seeks to supplement existing right for mitigation purposes only and is limited to the extent of historic senior water diversions associated with Willow Field.
