

Pipeline currently exists which conveys water from Spring [C] to trough located at the POU in Section 31 of T.27N., R.40E. M.D.B.&M. Portion of waters from Jersey Hot Spring - Spring [F] will be diverted through a temporary pipeline, which will then enter the existing Spring [C] pipeline. This temporary application is being filed due to Spring [C] running dry for the first time in 100 years. Portion of water will temporarily be diverted from Jersey Hot Spring - Spring [F] through temporary pipeline (to be installed in period of 1 week) and enter existing Spring [C] pipeline, where it will exit into existing trough at the Place of Use in Section 31 of T.27N., R.40E. M.D.B.&M.
