
This application to change the point of diversion and place of use of a portion of Permit 69874 is intended to remove 0.3249 cfs from the original Point of Diversion and 65.53 acres from the original Place of Use. This water is to be added to the same Place of Use and Point of Diversion as Permit 68304 to increase the existing duty from 3 ac-ft/ac to 4.4 ac-ft/ac and also increase the Place of Use by 6.5 acres which is the true area of the existing pivots. The 6.5 acres is being added at 4.4 ac-ft/ac.

16. Miscellaneous remarks:

The equivalent portions of water from Permit 69873 that share the same place of use as the water being changed by this application will also be moved by a separate application to change. We are aware there will be left over water remaining that is both stand alone and supplemental that will not be moved by this change application.
