APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of a portion of the waters of an underground source as heretofore granted under Permit 15607, Certificate 5113 is issued subject to the terms and conditions imposed in said Permit 15607, Certificate 5113 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 30 days after the end of each calendar quarter.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of surface water under Permits 83524, 83525, 83526, and 83527 shall not exceed 1,052.5 acre-feet as decreed.

The total combined duty of surface water under Permits 83524, 83525, 83526, and 83527 and supplemental groundwater under Permits 83528, 83529, 83530, and 83531 shall not exceed 1,766.76 acre-feet for the irrigation of 441.69 acres within the described place of use.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Temporary Permit 83640T will expire upon approval of this permit.

The proposed place of use of this permit has underlying surface water and is fully supplemental to waters of the Rebel Creek Decree, under Permits 83524, 83525, 83526 and 83527. All surface water rights must be fully utilized and the groundwater may be diverted only to the extent that surface water is not available.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 2.28 cubic feet per second or 874.76 acre-feet annually, but not to exceed 4.0 acre-feet per acre from all sources.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

October 10 2015

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:




