#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion of the waters of an underground source as heretofore granted under Permit 47989, Certificate 12755, is issued subject to the terms and conditions imposed in said Permit 47989, Certificate 12755, and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 29004, Certificate 12738; Permits 30426, 30428, Certificate 12739; Permit 30429, Certificate 12740; Permit 30510, Certificate 12741; Permit 30514, Certificate 12742; Permits 30515, 30516, Certificate 12743; Permits 31165, 31751, 35577, Certificate 13597; Permit 37177, Certificate 12745; Permits 38727, 41001, 41002, Certificate 12746; Permits 41003, 41004, Certificate 12747; Permits 41006, 41007, 41441, 41442, Certificate 12749; Permits 41443, 41444, Certificate 12750; Permit 41445, Certificate 12751; Permits 42786, 42787, 42788, 42988, 43086, 43087, 43088, 43089, 43090, 43091, 43092, 43093, 43094, 47986, 47987, Certificate 12754; Permit 47988, Permits 53775, 53776, 53777, 55132, 56333, 56750, 69183, 75407, 77118, 78312, 82137, 83601 and 83602 shall not exceed 16,091.6 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.8 cubic feet per second or 400.6 acre-feet annually.**




