#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 52025, is issued subject to the terms and conditions imposed in said Permit 52025 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 7381, Certificate 1207; Permit 9446, Certificate 2494; Permit 10185, Certificate 2744; Permit 14474, Certificate 4824; Permit 14475, Certificate 4825; Permit 14476, Certificate 4469; Permit 14477, Certificate 4470; Permit 15979, Certificate 5370; Permit 23985, Certificate 9848; Permit 24801, Certificate 7513; Permit 26326, Certificate 9790; Permit 29061, Certificate 8791; Permit 36626, Permit 37221, Certificate 11134; Permit 43373, Permit 43374, Permit 44073, Certificate 15990; Permit 48277, Certificate 13798; Permit 49515, Permit 51994, Certificate 17883; Permit 51995, Certificate 17884; Permit 52854, Permit 54142, Certificate 15991; Permit 56590, Permit 59766, Certificate 15995; Permits 61635, 61712, 61714, 64180, 67161, 74870, 76772, 76773, 77213, 77214, 77436, 83647 and 83648 shall not exceed 18,030.24 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.054 cubic feet per second or 15.122 acre-feet annually.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

September 17 2015

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:





Permits 52025 and 52026 were originally issued to Rex C. Claridge and Charles B. Evans and the well under these permits was drilled by them on lands controlled by them. Portions of Permits 52025 and 52026 were subsequently conveyed to the City of Elko in exchange for the City serving water to Sundance Estates Subdivision which is located near to but not served from the well under these permits. The City had been in negotiations to purchase the well from Claridge and Evans but has chosen not to do so. The lands where the well is located have subsequently been conveyed to others. Given the fact that the City has chosen not to purchase the well and the fact that the lands where the well is located have been deeded to another party we are filing this application to change the City's portion of Permit No. 52025 to a well controlled by the City and connected to the City's distribution system where it can be placed to beneficial use by the residents of the City of Elko. The annual consumptive use under this application will be 15.122 acre feet annually.
