APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 15224, Certificate 5017; is issued subject to the terms and conditions imposed in said Permit 15224, Certificate 5017; and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 83635T, 83651T and 83652T shall not exceed 502.4 acre-feet annually for the irrigation of 125.6 acres within the described place of use.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire 1 year after the approval of the permit at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit is also issued with the provision that the existing place of use from which water is being transferred shall not be placed to beneficial use under any other water right permits during the duration of this permit.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.416 cubic feet per second or 300.108 acre-feet annually, but not to exceed 4.0 acre-feet per acre from all sources.







16. Miscellaneous remarks

Proposed place of use has been historically irrigated. Historical use documented and filed under V-10493. Temporary change application 83246T filed on 11/8/2013 to temporarily change point of diversion for a portion of filed Vested Claim V-10493. 83246T is currently listed as RFA.

This temporary change application for 15224 as well as temporary change application being filed for 14670 and 28039 (being filed at same time as this temporary change application), are intended to irrigate the same proposed Place of Use and Point of Diversion as the proposed Place of Use and Point of Diversion as listed under previously filed 83246T.

This application is being filed to allow for immediate irrigation within the NW1/4 corner of Section 8. T. 42 N., R. 37 E., M.D.B.&M. Please note that there is no intent for these temporary change applications to 15224, 28039, and 14670 to be supplemental to previously filed temporary change application 83246T. It is wished that either temporary change applications to 15224, 28039, and 14670 be permitted as soon as possible or that 83246T is permitted as soon as possible so that irrigation can begin for the 2014 irrigation season within the proposed place of use. These temporary change applications to 15224, 28039, and 14670 are being filed in case 83246T is not permitted in time for the 2014 irrigation season.

Please note that the Brandt Ranch property has been purchased by Rodney and Virginia St. Clair, and Report of Conveyance has been filed to transfer both 15224 and 28039 into Rodney and Virginia St. Clair's name.
