This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the place of use of a portion of the waters of the Newlands Reclamation Project rights in the Truckee and Carson River final decrees and portions of Permit 47819, Certificate 13255; and Permit 55770, Certificate 15506; which changed the place of use of portions of the Newlands Reclamation Project rights in the Truckee and Carson River final decrees, is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on November 15, 2014 at which time all rights herein granted shall revert to the rights being changed by this temporary permit.

The point of diversion and place of use are as described on the submitted application to support this permit.





This temporary transfer is to supplement the water allocation for TCID serial numbers 111-1, 111-2, 111-3, 80. The water duty at the EPOU (TCID serial no. 145) is 3.5 and the duty at the PPOU is 3.5. Due to drought conditions, the total allocation for PPOU, including the 81.235 acre-feet being transferred under this application will not exceed 3.5 acre-feet per acre. The lands under the EPOU will have no water deliveries for the 2014 irrigation season if this application is permitted.
