APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 63665, is issued subject to the terms and conditions imposed in said Permit 63665 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The permittee shall keep monthly records of the amount of water pumped from this well and the records submitted to the State Engineer on an annual basis by February 15th of each year.

The total combined duty of water under Permits 63668, 63670, 63674, 63675, 63676, 78800, 78803, 78804, 78805, 78806, 78807, 78810, 84145, 84146, 84147, 84148, 84149, 84150, 84151, 84152, 84154, 84155, 84157, 84158, 84159, 84160, 84161, 84162, 84163, 84164, 84165, 84166, 84167, 84168, 84928T, 84930T, 84933T, 84934T, 84935T, 84949T, 84950T, 84951T, V09745, V09746, V09747, and V09748 shall not exceed 3,983.04 acre-feet annually for the irrigation of 1,285.76 acres.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.55 cubic feet per second or 99.0 acre-feet annually.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

June 19 2016

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

June 19 2018

Map in support of proof of beneficial use shall be filed on or before:


