Twin declines are to be constructed as part of new mining exploration. Water developed will be used in the drilling process, dust control, and exploration. Water use will be made in conjunction with Application to Change Permit 50683, being filed concurrently. The total combined duty under this Application and Application to Change Permit 50683 shall not exceed 124 million gallons annually (380.54 AFA). It is anticipated that the existing Point of Diversion will be utilized by Barrick - Cortez for stock purposes in the future.

Applicant and Barrick Cortez, Inc have entered into a Lease Agreement and Option to Purchase the base water right under this application - please refer to Lander County Document #0265076 recorded 9/20/2012 and Document #0271152 recorded 6/24/2014. 
