**APPROVAL OF STATE ENGINEER**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion and place of use of the waters of a portion of an underground source as heretofore granted under Permit 25679, Certificate 9295, is issued subject to the terms and conditions imposed in said Permit 25679, Certificate 9295, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire 1 year after the approval of the permit at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.163 cubic feet per second or 75.72 acre-feet annually, but not to exceed 4.0 acre-feet per acre from all sources.**





New center pivot and irrigation lines to be installed on Ranch to replace wheel line irrigation. Irrigation of pivot to occur through use of existing well, pump, and motor. Permanent change applications to be filed in the future. New proposed center pivot to be irrigated with a combination of portions of existing certificated groundwater rights, and temporary change applications to certificated water rights. Center pivot will be fully irrigated by groundwater. Portion of Water Rights moved under Permit 25679 to remain supplemental to surface water. Please see "Attachment A".

16. Miscellaneous remarks:

Permit 25678/Cert. 9294 (Surface Water) shares a common place of use with Permit 25679/Cert. 9295 (Groundwater) and Permit 25680/Cert. 9296 (Groundwater). A portion of Permit 25679 is to be stripped under this temporary app. with the understanding that Permit 25680 will not be used on lands that are temporarily stripped from Permit 25679 or 25678.




Proposed Place of Use of Permit 18524 / Certificate 6138 [5.289 Ac] (Permit 18524 is Sole Source GW)
