This application is being filed to transfer an existing groundwater permit to land within the Smoke Creek Desert Basin upon which it can be beneficially applied. Permit 75403 is supplemental to surface rights and will continue to be supplemental to all surface rights within the proposed place of use under Permit 65002 and Proofs 09120 and 09121. The total combined duty of this application and Permit 65002 is not to exceed 4800 acre-feet annually from any and all sources. The place of use is owned by Bright-Holland Co. Bright-Holland Co. has granted permission to Jackrabbit Properties, LLC to transfer this water to the place of use.
