#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of the waters of Knott Creek as heretofore granted under Permit 62585, Certificate 15368, is issued subject to the terms and conditions imposed in said Permit 62585, Certificate 15368 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water herein granted at any and all times.

The total combined duty of surface water under Permits 84341, 84342, 84345 and 84352 and supplemental groundwater under Permits 84339, 84340, 84343, 84344, 84346, 84347, 84348, 84349, 84350, and 84351 shall not exceed 8,127.99 acre-feet for the irrigation of 2,535.13 acres within the described place of use. Supplemental groundwater shall not be pumped from the wells described in these permits except to the extent necessary to make up the portion of the entitled duty of surface water under Permits 84341, 84342, 84345, and 84352 in any given year.

A monthly report shall be submitted to the State Engineer on an annual basis by February 15th of each year which shall include the amount of water diverted and the amount of water used.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 5.56 cubic feet per second or 4,025.27 acre-feet per season, but not to exceed 4.0 acre-feet per acre from all sources.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

April 15 2016

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:






