APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This primary permit, to change the point of diversion, place and manner of use of the waters of the Truckee River as heretofore granted under Permit 48061, Certificate 19467, is issued subject to the terms and conditions imposed in said permit and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water diverted into storage and released from storage must be recorded.

This primary permit is issued under the authority of NRS 533.440 (secondary applications are required for the use of the stored water) and is only a temporary allowance. The final water right obtained will be dependent upon the amount of water actually placed to beneficial use under the secondary permits. Accurate measurements of the storage water that is discharged must be recorded. The State retains the right to regulate the use of water herein granted at any and all times. This permit is subject to the continuing jurisdiction and regulation by the State Engineer and the Federal Water Master.

A monthly report shall be submitted to the State Engineer and the Federal Water Master within 10 days from the end of each month and shall include the amount of water diverted into storage and the amount of water used under each secondary permit.

The total combined duty of water under Permits 84356 and 84357 shall not exceed a maximum diversion rate of 3,000 cubic feet per second, but not to exceed 477,851 acre-feet annually.

This permit is hereby issued and becomes effective upon proof that the Orr Ditch Decree has been amended and TROA is fully implemented. The base right to this permit remains in full force and effect until such time that this permit becomes effective.

No more than 25 percent of any water right can be taken into storage in any one month.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 3,000.0 cubic feet per second or 477,851.0 acre-feet annually.**







The following describes the points of diversion for the lower Truckee River and Pyramid Lake which are shown on the supporting maps filed under Application Nos. 48061 and 48494 in the office of the Division of Water Resources, State of Nevada, more particularly described as follows:

1. The Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 17 (projected), Township 23 North, Range 23 East, M.D.B.&M., of unsurveyed land, being South $79^{\circ} 04' 34''$ West, 7,616.79 feet from the East $\frac{1}{4}$ of Section 16, Township 23 North, Range 23 East, M.D.B.&M. (see below) ✕
2. Within the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 15, Township 23 North, Range 23 East, M.D.B.&M., being South $23^{\circ} 49' 49''$ East, 2,677.00 feet from the West $\frac{1}{4}$ corner of said Section 15. (see Application 84357)

SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 17 (Projected), T.23N., R.23E., M.D.B.&M., or at a point from which the E $\frac{1}{4}$ corner of Section 16, T.23N., R.23E., M.D.B.&M., bears N. $79^{\circ} 04' 34''$ E., a distance of 7,616.79 feet situated in Washoe County, State of Nevada.

The Proposed Points of Diversion (Dam) are shown on the map filed with Amended Application No. 73783 and the storage capacity (AF) and maximum outlet capacity (cfs) for each Storage Reservoir are as follows:

Lake Tahoe:

Situate in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 7, T. 15N., R. 17E., M.D.M., or from the Dam the Southwest corner of said Section 7 bears South $29^{\circ} 09' 30''$ West a distance of 5,182 feet, more or less. The storage capacity of Lake Tahoe is approximately 744,600 AF with a maximum outlet capacity of 2,500 cfs.

Donner Lake:

Situate in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 18, T. 17N., R. 16E., M.D.M., or from the Dam the Southeast corner of said Section 18 bears South $04^{\circ} 07' 14''$ East a distance of 2,981 feet, more or less. The storage capacity of Donner Lake is approximately 9,500 AF with a maximum outlet capacity of 660 cfs.

Prosser Creek Dam (Reservoir):

Situate in the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 30, T. 18N., R. 17E., M.D.M., or from the Dam the southwest corner of said Section 30 bears South $22^{\circ} 58' 48''$ West a distance of 2,006 feet, more or less. The storage capacity of Prosser Creek Reservoir is approximately 29,840 AF with a maximum outlet capacity of 1,850 cfs.

Boca Dam (Reservoir):

Situate in the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 21, T. 18N., R. 17E., M.D.M., or from the Dam the southwest corner of said Section 21 bears South $81^{\circ} 05' 07''$ West a distance of 2,647 feet, more or less. The storage capacity of Boca Reservoir is approximately 40,870 AF with a maximum outlet capacity of 1,200 cfs.

Stampede Dam (Reservoir):

Situate in the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 28, T. 19N., R. 17E., M.D.M., or from the Dam the northwest corner of said Section 28 bears North $36^{\circ} 08' 27''$ West a distance of 636 feet, more or less. The storage capacity of Stampede Reservoir is approximately 226,500 AF with a maximum outlet capacity of 2,740 cfs.

Independence Lake Dam:

Situate in the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 35, T. 19N., R. 15E., M.D.M., or from the Dam the Southwest corner of said Section 35 bears South $20^{\circ} 06' 47''$ West a distance of 1,945 feet, more or less. The storage capacity of Independence Lake is approximately 17,500 AF with a maximum outlet capacity of 540 cfs.

16. Remarks

This application is filed pursuant to the provisions of N.R.S. §533.515 in that it seeks to add the reservoirs described in Exhibit B and as listed in Item 11 above as additional points of diversion for the water rights described herein and would be the water that would have otherwise flowed to Pyramid Lake, and which water rights have points of diversion in the State of Nevada. This application is also filed as part of the implementation of the operating agreement described in Section 205(a) of Public Law 101-618. Because of the provisions of California Water Code section 1231 and 1232, California will recognize any permits issued by the Nevada State Engineer based upon this application. Therefore, it is within the jurisdiction of the Nevada State Engineer to approve this application allowing for storage of these Nevada water rights in California.

Water diverted to storage under a permit issued hereunder will be and is the subject of applications for secondary permits for beneficial uses allowed by the Truckee River Operating Agreement at the places allowed by that Agreement. The amount of water diverted to storage under a permit issued hereunder in any one year will be 3,000 cfs but not to exceed 477,851 acre-feet for water rights under Permit Nos. 48061 and 48494 combined. The amount of water under a permit issued hereunder which may be in storage at any one time and which may be released and used from storage in any one year will not exceed the amounts allowed by the Truckee River Operating Agreement.

Under conditions where storage of this water in the upstream reservoirs is not desired or warranted, water will remain in the Truckee River for the purpose of storage in Pyramid Lake, in which case this quantity of water will remain in the River flowing past Derby Dam to Pyramid Lake. If the water right described herein is not diverted to upstream storage, the full amount of the water right will continue to flow to Pyramid Lake for storage and beneficial use within the lower Truckee River and Pyramid Lake.

Any permit issued under this application shall enter into effect simultaneously with the entry into effect of the Truckee River Operating Agreement.
