APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of the waters of an underground source as heretofore granted under Permit 35256, Certificate 12847, is issued subject to the terms and conditions imposed in said Permit 35256, Certificate 12847 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permits 84387, 84388 and 84389 shall not exceed 813.4 acre-feet annually for the irrigation of 162.68 acres within the described place of use.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 1.11 cubic feet per second or 792.0 acre-feet annually, but not to exceed 5.0 acre-feet per acre from all sources.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

April 14 2016

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:





AFFIDAVIT OF TERRY F. RUDD

I, Terry F. Rudd, being duly sworn, hereby depose and say:

1. I make this affidavit on behalf of Corporation of the Presiding Bishop of The Church of Jesus Christ of Latter-day Saints ("CPB"), as its Authorized Agent.

2. CPB is a Utah corporation sole, a special type of non-profit corporation used by churches and other religious societies. The Presiding Bishop of The Church of Jesus Christ of Latter-day Saints (the "Church") serves as CPB's "incumbent" (essentially, the corporation's sole director). CPB is the principal entity through which the Church owns real property and conducts its temporal affairs. The Church's Presiding Bishop and his two counselors (assistants) form the Church's Presiding Bishopric, which reports to the Church's President and his two counselors (the "First Presidency"), the Church's senior governing council.


3. Farmland Reserve is a Utah non-profit corporation formed to benefit, perform the functions of, and otherwise carry out the purposes of the Church. Its directors are appointed by and serve at the pleasure of the Church's First Presidency. Currently, the Church's Presiding Bishopric and the managing director of Church Investment Farms serve as Farmland Reserve's directors.

4. CPB and FRI are both corporations formed to carry out the functions and purposes of the Church.

5. This affidavit is made for the purpose of showing the relationship between CPB and FRI with the Church for sole purpose of amending the place of use for Nevada State Permit No. 28642, Certificate 9636, Nevada State Permit No. 52120, Certificate 14481, and Nevada State Permit No. 35256, Certificate 12847, and this affidavit may be relied upon only by the State of Nevada Division of Water Resources.
