APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the place and manner of use of the waters of Sheridan Creek, as heretofore appropriated under Proof V06339 as appears in the Findings of Fact, Conclusions of Law Judgment and Decree in the Matter of the Determination of the Relative Rights in and to the Waters of Mott Creek, et. al., in the Ninth Judicial District Court of the State of Nevada, in and for the County of Douglas, is issued subject to the terms, conditions and irrigation period imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be temporarily transferred shall consist of the full flow of Stutler Creek and the commingled waters of the north split of Sheridan Creek and Gansberg Spring in a rotation scheme of distribution. This water may be diverted during the time allotted to the Pestana property, further described as Douglas County Assessor's Parcel No. 1219-14-001-014, consisting of 23.76 acres of water-righted ground. This permit is issued subject to the approval of the modified irrigation rotation schedule by the Ninth Judicial District Court of the State of Nevada In and For Douglas County, Case No. : 08-CV-0363-D; Dept. No. 1, which includes the Pestana property. These rights may be placed to use on the Bentley parcel and are subject to the same sharing agreement as set forth in the 2015 irrigation schedule.

This temporary permit shall be initiated only at the beginning of one of the 21-day irrigation rotation cycles occurring between April 1, 2015 and October 15, 2015. Further, these rights may be shared as set forth under the modified rotation schedule.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire October 15, 2015, at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.






