APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 79724, is issued subject to the terms and conditions imposed in said Permit 79724 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The permittee shall keep monthly records of the amount of water pumped from this well and the records submitted to the State Engineer on an annual basis by February 15th of each year.

The total combined duty of water under Permit 920, Certificate 866; Permit 15812, Certificate 4808; Permit 17163, Certificate 4810; Permit 20817, Certificate 6777; Permit 22545, Certificate 7571; Permit 26228, Certificate 8363; Permit 26229, Certificate 8364; Permit 26546, Certificate 8365; Permit 26952, Certificate 8366; Permit 26953, Certificate 8367; Permit 29162, Certificate 10107; Permit 34727, Certificate 11889; Permit 50772, Certificate 14454; Permit 78107, Temporary Permits 84961T, 84962T, 84964T, 84965T and 84971T shall not exceed 3,482.806 acre-feet annually.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire 1 year after the approval of the permit at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.071858 cubic feet per second or 51.996 acre-feet annually, but not to exceed 4.0 acre-feet per acre from all sources.**






Currently, Wahoo Ranch has excess water rights available to transfer neighboring Harbecke Ranch due to changes in irrigation practices at Wahoo Ranch. In past years, temporary applications have been filed to balance water rights within Harbecke and Wahoo Ranches. This application is intended to temporarily move a portion of water rights from Wahoo Ranch to Harbecke Ranch, where it can be used beneficially. All works have already been completed at this time.

16. Miscellaneous remarks:

Per analysis, excess water rights are available at Wahoo No. 3 to transfer to new well SPR 70351 at bordering Harbecke Ranch. In previous irrigation seasons, temporary applications have been filed to transfer water rights to SPR 70351. This application will temporarily transfer 51.996 AFA from the TCD term of Permit 79724 to SPR 70351. See Attachment "A".
