APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 80868, is issued subject to the terms and conditions imposed in said Permit 80868 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The well must be sealed from ground level to 100 feet in accordance with NAC 534.380.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.15 cubic feet per second or 18.0 acre-feet annually, but not to exceed 3.0 acre-feet per acre.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

January 4 2018

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:





A portion of the NW1/4 SE1/4 of Section 23, T.33 N., R.57 E., M.D.B. & M., being a portion of that 14.829 acre adjusted parcel as shown on the Boundary Line Adjustment Record of Survey for The Kuhl Family Living Trust, Elko County Recorder File No. 456976, also being a portion of Elko County Assessor's Parcel No. 006-52D-026.
6.0 acres to be irrigated.

The total existing place of use of Permit 80868 is comprised of four separate legal parcels being Elko County Assessor's Parcel No.'s 006-52D-025, 006-52D-026, 006-52D-040 and 006-52D-046, all of which are owned by the applicant. We are filing this application and other applications being filed herewith changing the point of diversion and place of use of a portion of Permit 80868 to enable the owner of each of the separate parcels, if transferred, to drill a well on that parcel and irrigate the parcel on a separate and individual basis. The applicants are in the process of adjusting the boundary line between APN 006-52D-025 and 006-52D-026 so that the proposed place of use and resultant parcel boundaries will be the same.
6.0 acres are to be irrigated from the well at the proposed point of diversion within the proposed place of use. This well is also to be used for domestic purposes on the existing parcel.
