This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the place of use of a portion of the waters of the Newlands Reclamation Project rights in the Truckee and Carson River final decrees and portions of Permit 47804, Certificate 16460; Permit 47840, Certificate 16246; Permit 47862, Certificate 16312; Permit 47865, Permit 49112, Certificate 16328; Permit 49284, Certificate 14880; Permit 50009, Certificate 16329; Permit 50029, Certificate 15315; Permit 63107, Certificate 16244 and Permit 69322 which changed the place of use of a portion the Newlands Reclamation Project rights in the Truckee and Carson River final decrees is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on November 15, 2015, at which time all rights herein granted shall revert to the right being changed by this temporary permit.

A portion of this temporary Permit is issued under the provisions of NRS 533.040 Paragraph 4 and is limited to the irrigation of 15 acres within the proposed place of use in sections 21, 22, 27, 28, 33 and 34, T.20 N., R. 29 E.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.




