APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 26502, Certificate 9300, is issued subject to the terms and conditions imposed in said Permit 26502, Certificate 9300, and with the understanding that no other rights on the source will be affected by the change proposed herein. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under Permit 920, Certificate 866; Permit 15812, Certificate 4808; Permit 17163, Certificate 4810; Permit 20817, Certificate 6777; Permit 22545, Certificate 7571; Permit 26228, Certificate 8363; Permit 26229, Certificate 8364; Permit 26502, Certificate 9300; Permit 26546, Certificate 8365; Permit 26952, Certificate 8366; Permit 26953, Certificate 8367; Permit 29162, Certificate 10107; Permit 34727, Certificate 11889; Permit 50772, Certificate 14454; Permits 78107, 85107, 85108, 85109, 85110, and 85111 shall not exceed 3,504.29 acre-feet annually for the irrigation of 876.0725 acres within the described place of use known as the Herbecke Ranch.

The permittee shall keep monthly records of the amount of water pumped from this well and the records submitted to the State Engineer on an annual basis by February 15th of each year.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, not to exceed 0.27 cubic feet per second or 73.48 acre-feet annually, and is limited to 4.0 acre-feet per acre from all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

October 25 2017

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:




