#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to NRS 533.504 and is subject all existing rights on the source. It is understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other groundwater development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The issuance of Permit 85118 shall expire Temporary Permit 85117T.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **not to exceed 0.025 cubic feet per second and 17.92 acre-feet annually, or sufficient to water 800 head of cattle.**

November 16 2017

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:






