**APPROVAL OF STATE ENGINEER**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the place of use of a portion of the waters of the Humboldt River as heretofore appropriated under Proof DHR00122 as appears in the Matter of the Determination of the Relative Rights of the Water of the Humboldt River Stream System and Tributaries, Case No. 2804, in the District Court of the Sixth Judicial District of the State of Nevada, in and for the County of Humboldt, is issued subject to the terms, conditions and irrigation period imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed at or near the point of diversion to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water herein granted at any and all times.

Temporary Permits 85058T through 85065T, 85078T and 85155T shall be limited to 6,040.41 acre-feet per season strictly from surface water sources, 3,010.38 acre-feet per season from supplemental underground sources, and 67.24 acre-feet per season from non-supplemental underground sources for a total combined duty from all sources not to exceed 6,107.65 acre-feet per season.

The total combined duty from underground sources shall not exceed 3,077.62 acre-feet per season.

Temporary Permits 85058T through 85065T, 85078T and 85155T shall be limited to 1,754.1 acres strictly from surface water sources, plus 1,003.46 acres from supplemental underground and surface water sources, plus 22.6 acres from non-supplemental underground sources, for a total of 2,780.16 acres irrigated from all sources within the common place of use described in the applications.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire at the end of the irrigation season as decreed or September 15, 2015, whichever is sooner, at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.



In an effort to improve the irrigation efficiency of the ranch, a modernized pivot irrigation system was installed over areas that were previously flood irrigated. The surface water canal system has not been removed as a result of the installation of the modernized pivot system. This application proposes to change the place of use of the existing surface water rights in conjunction with the corresponding supplemental groundwater rights as a result of the new irrigation practice. A total of 892.59 acre-feet for 312.28 acres, as further calculated below, will be moved to the proposed place of use.


