APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion of the waters of an underground source as heretofore granted under Permit 69197, Certificate 18142, is issued subject to the terms and conditions imposed in said Permit 69197, Certificate 18142 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The permittee shall keep monthly records of the amount of water pumped from this well and the records submitted to the State Engineer on an annual basis by February 15th of each year.

The total combined duty of water under Permits 81254, 81298, 81299, 85181, 85182, 85183, 85184, 84185 and 85186, shall not exceed 409.85 acre-feet annually.

If any water under this permit is cancelled or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.205 cubic feet per second or 129.85 acre-feet annually.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

June 21, 2016

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:





All infrastructure and water use on the site is existing. This change application is to move existing water rights into a different well on the same golf course, in which supplemental rights are already appurtenant. The owner has seven supplemental water rights permits spread over three wells to serve the Mountain Falls Golf Course. The newest of the three wells (the proposed POD under this change application) produces artesian flow, and the older two wells are used to supplement the more productive artesian well to irrigate the golf course. It is the owner's intention to move all seven permits into the artesian well, then file for diversion rate only for the other two wells to allow for more flexibility in operations.
