APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 18786, Certificate 5756, is issued subject to the terms and conditions imposed in said Permit 18786, Certificate 5756 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under Permit 18786, Certificate 5756; Permit 18787, Certificate 5757; Temporary Permits 85212T and 85213T shall not exceed 1,280 acre-feet annually.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire 1 year after the approval of the permit at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.67 cubic feet per second or 640 acre-feet annually, but not to exceed 4.0 acre-feet per acre from all sources.





Permit 18786, Certificate 5756 and Permit 18787, Certificate 5757 are issued for the irrigation of 320 acres within the N1/2 of Section 13, T.21 N., R.53 E., M.D.B. & M. The wells under these permits have declined in production and will no longer efficiently irrigate the total acreage certificated. We are filing this application and an application changing the point of diversion of a portion of Permit 18787 in order to drill two new wells to aid in the irrigation of the total acreage allowed. This application for a temporary permit is being filed to take advantage of the well driller's availability with the anticipation that the new wells can be drilled and utilized for the remainder of the irrigation season. The waters under this application, the water under the accompanying application changing the point of diversion of a portion of Permit 18787, and the waters remaining at the existing points of diversion of Permits 18786 and 18787 are to be co-mingled for the irrigation of 320 acres within the proposed place of use.


