This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 58254, is issued subject to the terms and conditions imposed in said Permit 58254 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of water herein granted at any and all times.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire 1 year after the approval of the permit at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.





This Application is being filed in support of an agreement between the mine and the owner of the stockwater grazing allotment. Applicants will provide stockwater to Grazing Permittee 26 Ranch periodically when cattle are moved in the area around the mine. It is anticipated that approximately 5,000 head of cattle will utilize this stockwater well for approximately 20 days each year. An Affidavit in Support of Stockwater Application is on file under Permit 84410T. The temporary permit issued under this application will expire Permit 84410T and allow for stock water use during the ensuing 12 months.

16. Miscellaneous remarks:

Applicants are operating under a joint venture, the Barrick-Dee Mining Venture (BDMV) between Barrick Gold Exploration Inc. and Goldrock Dee LLC, successor to Glamis Marigold Mining Company and Rayrock Dee Mines. Barrick Gold Exploration Inc. is the manager of the Arturo Mine Project.
