APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place and manner of use of a portion of the waters of the Truckee River as heretofore granted under Claims 303/404, 305 and 316, Truckee River Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

The issuance of this permit fully abrogates 63.88 acre-feet per season associated with 15.96 acres under Claims 303/404, 305 and 316, being described as the existing place of use under this permit.

The issuance of this permit is for the consumptive use portion only, being 2.50 acre-feet per acre of the base right. The remaining portion of the base right will remain in the river for use by other decreed right holders.

This permit is subject to the continuing jurisdiction of the Federal Water Master and the State Engineer.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2946 cubic feet per second or 39.90 acre-feet as decreed.






