**APPROVAL OF STATE ENGINEER**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the point of diversion, place and manner of use of a portion of the waters of the Truckee River as heretofore granted under Permit 11009, Certificate 2821, which changed the point of diversion and place of use of a portion of Claim 342, Truckee River Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

The issuance of this permit fully abrogates 4.47 acre-feet per season associated with 1.19 acres under Permit 11009, Certificate 2821, being described as the existing place of use under this permit.

The issuance of this permit is for the consumptive use portion only, being 2.50 acre-feet per acre of the base right. The remaining portion of the base right will remain in the river for use by other decreed right holders.

This permit is subject to the continuing jurisdiction of the Federal Water Master and the State Engineer.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.027 cubic feet per second or 2.975 acre-feet as decreed.



There will be no physical diversion. The water is to remain in the Truckee River stream channel from the existing permitted point(s) of diversion to Pyramid Lake to be used for wildlife, including instream flows for fish (cui-ui and Lahontan cutthroat trout)

Permit 11009 changed a portion of DTR Claim 342 from the Spanish Springs Valley Ditch which diverts water from the Truckee River via the Orr Ditch. This applications transfers the point of diversion back to the Decreed point of diversion under said DTR Claim 342

16. Miscellaneous remarks:

The summary of ownership for Permit 11009 incorrectly assigns only 3.08 AF under Permit 11009. This permit is supplemental to DTR Claim 138. Please refer to submittal for said Claim and for Permit 11009 dated 6/30/2009 and subsequent assignment letters for both rights dated 10/8/2009 and 10/20/2009, respectively.
