APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of a portion of the waters of an underground source as heretofore granted under Permit 30259, Certificate 10421, is issued subject to the terms and conditions imposed in said Permit 30259, Certificate 10421 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The well must be sealed from ground level to 100 feet in accordance with NAC 534.380.

The total combined duty of water under Permits 85778 and 85779 shall not exceed 1,346.4 acre-feet for the irrigation of 336.6 acres.

The total land irrigated under Permits 85778 and 85779 and any water of the Walker River Decree and any storage water appurtenant to the place of use shall not exceed 336.6 acres within the described place of use. These permits for underground water are issued as a supplemental water supply to lands that have surface water rights from the Walker River as set forth in Claim Numbers 45, 65 and 153 of the Walker River Decree C-125, or from storage water provided from the Walker River Irrigation District. The total diversion of water from this supplemental permit shall not exceed 4.0 acre-feet per acre, and is limited to the extent necessary to make up a portion of 4.0 acre-feet per acre when combined with the entitled Decree and storage water during any given year. In the event that 4.0 acre-feet per acre is delivered from surface sources, this supplemental underground right shall not be pumped.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 2.9982 cubic feet per second or 672.8 acre-feet per season.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

August 12 2017

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

August 12 2021

Map in support of proof of beneficial use shall be filed on or before:


