The point of diversion and place of use of this application is located at the City of Elko Sewer
Treatment Plant. The City was granted waivers to drill shallow dewatering wells at the plant to
accommodate recent construction activities. These wells were utilized to dewater shallow
underground waters during construction. They now desire to utilize these wells on an annual basis for
maintenance purposes at the facility. This application is being filed to change a portion of Permit
36626 which is controlled by the City for dewatering purposes as a beneficial use per NRS 534.025.
The wells will be utilized at a duty of 13.26 acre feet annually to allow the City to perform maintenance
activities at the plant. Any portion of the 13.26 acre feet requested that is not utilized consumptively
will be transferred to the City's rapid infiltration basins or settling ponds to be returned to the source.


