APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 63769, Certificate 15809, is issued subject to the terms and conditions imposed in said Permit 63769, Certificate 15809, and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under Permit 61932, Certificate 15806; Permit 62821, Certificate 15807; Permit 63768, Certificate 15808; Permit 63769, Certificate 15809; Permit 67043, Certificate 16888; Permit 67846, Certificate 16889; Permit 67847, Certificate 16890; Permit 70100, Certificate 18184; Permit 70101, Certificate 18185; and Permits 82523, 86162T and 86163T shall not exceed 668.42 acre-feet annually.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire 1 year after the approval of the permit at which time all rights herein granted shall revert to the right being changed by this temporary permit.

This permit is issued for recreational purposes within the described place of use, further identified as Clark County Assessor's Parcel Numbers 124-36-102-001 and 124-36-502-001, aka Shadow Creek Golf Course.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.


