APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of the waters of an underground source as heretofore granted under Permit 24363, Certificate 8195, is issued subject to the terms and conditions imposed in said Permit 24363, Certificate 8195 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is also issued subject to the provision that the place of use of the water herein granted is limited to and supplemental, in part, to lands having existing surface water rights from Angel Creek.

The total combined duty of water under Permits 86425, 86426, and 86427 shall not exceed 1,608 acre-feet annually for the irrigation of 402 acres within the described place of use.

Underground Permits 86425, 86426, and 86427 have 276.76 acres which are supplemental to the surface waters of V04091 (Angel Creek). Permits 86425 and 86426 have 205.17 acres of supplemental water and Permit 86427 have 71.59 acres of supplemental water. Those 276.76 acres irrigated by supplemental underground water may only be utilized in areas also irrigated by the waters of Angel Creek, and may be used only if surface water is not available.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, not to exceed 1.68 cubic feet per second or 912.0 acre-feet annually, and is limited to 4.0 acre-feet per acre from all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

January 31 2018

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:




Over time the availability of water from Angel Creek under Vested Proof V04091 has diminished and, as a result, the locations of irrigated acreage have been adjusted. Applications to change under Permit Nos. 24362, Certificate 8194; 24363, Certificate 8195; and 29684, Certificate 8921 are being filed to address a change in the place of use. All wells under these applications are existing points of diversion; no additional wells or additional volume of water are being requested.

16. Miscellaneous remarks:

Applications to change under Permit Nos. 24362, Certificate 8194; 24363, Certificate 8195; and 29684, Certificate 8921 will be commingled and will not exceed a duty of 4.0 acre-feet per acre from all sources.
