

**THE STATE OF NEVADA
CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Robert N. Caldwell, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation purposes. The point of diversion of water from the source is as follows: NE 1/4 SW 1/4 Section 10, T.37N., R.42E., M.D.B.&M., or at a point from which the NE corner of said Section 10 bears N. 88° 49' E., a distance of 2,727.2 feet situated in Humboldt County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*This certificate changes the point of diversion of a portion of Permit 28763 which changed the point of diversion and place of use of Permit 27078, Certificate 8449, which changed the place of use of Permit 22654, therefore, the date of priority remains the same as Permit 22654.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
