CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, B. J. Vasey, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows: NW 1/4 SW 1/4 Section 19, T.40N., R.40E., M.D.B.&M., or at a point from which the S 1/2 corner of Section 35, T.40N., R.39E., M.D.B.&M., bears S. 35° 15' W., a distance of 15630.0 feet situated in Humboldt County, State of Nevada.

Now Know Ye, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

40.0 acres in the NE 1/4 SW 1/4 of Section 19, T.40N., R.40E., M.D.B.&M.
5.0 acres in the NW 1/4 SW 1/4 of Section 19, T.40N., R.40E., M.D.B.&M.
10.3 acres in the SE 1/4 SW 1/4 of Section 19, T.40N., R.40E., M.D.B.&M.
5.4 acres in the SW 1/4 SE 1/4 of Section 19, T.40N., R.40E., M.D.B.&M.
127.0 acres total

*This certificate changes the point of diversion and place of use of a portion of Permit 26066, therefore the date of priority remains the same as Permit 26066.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water from any and/or all sources shall not exceed 3.6 acre feet per acre per annum.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
