CERTIFICATE OF APPROPRIATION OF WATER

Under the provisions of NRS 533.425, the State Engineer has determined:

The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 3, T.39N., R.41E., M.D.B.&M., or at a point from which the E $\frac{1}{4}$ corner of said Section 3 bears S. 66°00' E., a distance of 2,830.0 feet situated in Humboldt County, State of Nevada.

Manner of use: **Irrigation**

Description of the works of diversion and the manner and place of use:

Water is developed by means of a drilled well of unknown depth and diameter, equipped with a pump and motor thence through a distribution system for pivot sprinkler irrigation of barley on the following described land to which the water is appurtenant:

This certificate is issued subject to the terms of the permit and specifically subject to the following terms:


The total annual duty of water shall not exceed 4.0 acre-feet per acre of land irrigated from all sources.
