CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George H. Denson, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows: NW 1/4 NW 1/4 (Lot 1) Section 7, T.13N., R.26E., M.D.B.&M., or at a point from which the NW corner of said Section 7 bears N. 38° 53' 32" W., a distance of 1,595.02 feet situated in Lyon County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Joseph G. and Beverly J. Landolt, an undivided 1/2 interest and David A. Landolt, an undivided 1/2 interest
Post-office address: Yerington, Nevada
Amount of appropriation: 6.0 c.f.s., but not to exceed 1,448.8 acre-feet per annum
Period of use, from: January 1st to December 31st of each year
Date of priority of appropriation: March 8, 1976

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
