CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, C. H. Ketcham, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source

through a drilled well, pump and distribution system for Irrigation

purposes. The point of diversion of water from the source is as follows: SE 1/4 SE 1/4 Section 17, T.42N., R.37E., M.D.B.&M., or at a point from which the S 1/4 corner of said Section 17 bears S. 80° 10' W., a distance of 2,622.9 feet

situated in Humboldt County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*The total combined rate of diversion granted under this certificate and any certificate issued under Permits 28220, 28221, 28222, 28223, 28224, 28226, 28227, 28228, 29068 and 36241 shall not exceed 22.35 c.f.s. and the total combined duty on the above listed permits shall not exceed 5,456.84 acre-feet annually on a total of 1,370.09 acres.

**This certificate changes the place of use of a portion of Permit 17210, Certificate 5891, therefore, the date of priority remains the same as Permit 17210, Certificate 5891.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
