CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, R. LeRoy Givens, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation (Recreation-Golf Course) purposes. The point of diversion of water from the source is as follows: SW 1/4 SW 1/4 Section 21, T.21S., R.61E., M.D.B.&M., or at a point from which the S 1/4 corner of said Section 21 bears S. 69° 03' 40" E., a distance of 2,096.6 feet situated in Clark County, State of Nevada.

Now Know YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows: Name of appropriator Eugene R. \*The total duty of water for the land described under the place of use under this certificate shall not exceed 719.78 acre-feet annually from any and/or all sources.

\*\*This certificate changes the point of diversion of Permit 18263, Certificate 5607, which changed the point of diversion, place of use and manner of use of a portion of Permit 12869, therefore, the date of priority remains the same as Permit 12869.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
