CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Alex Grant, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows: SE 1/4 NW 1/4 Section 34, T.13N., R.23E., M.D.B.&M., or at a point from which the NW corner of said Section 34 bears N. 45° 56' W., a distance of 1930.0 feet situated in Lyon County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*This certificate changes the point of diversion and place of use of a portion of Permit 28183, therefore the date of priority remains the same as Permit 28183.

**The total combined rate of diversion under this certificate and any certificate issued under Permits 37029 and 37032 is limited to 4.57 c.f.s. The total combined annual duty of water granted under this certificate and any certificate issued under Permits 37029 and 37032 is 957.60 acre-feet.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
