CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Alan S. Boyack, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows: Lot 5 (SW 1/4 NW 1/4) Section 29, T.20N., R.53E., M.D.B.&M., or at a point from which the W 1/4 corner of said Section 29 bears S. 38° 51' 00" W., a distance of 81.00 feet situated in Eureka County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*This certificate changes the place of use of Permit 23984, Certificate 8799, therefore the date of priority remains the same as Permit 23984, Certificate 8799.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per season from any and/or all sources.

The total land to be irrigated under this certificate and any certificates issued under Permits 47518, 47519 and 47521 shall not exceed 317.54 acres and the total combined duty of this certificate and any certificates issued under these permits shall not exceed 1270.16 acre-feet seasonally.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
