CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Eugene B. Longfield, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Commercial (Dust Control Gravel Pit Operation) and Domestic purposes. The point of diversion of water from the source is as follows: SE 1/4 NE 1/4 Section 15, T.21N., R.20E., M.D.B.&M., or at a point from which the E 1/4 corner of said Section 15 bears N. 86° 50' 28" W., a distance of 1,093.7 feet situated in Washoe County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation 0.38 c.f.s. but not to exceed 108.53 acre-feet annually  
Period of use, from January 1st to December 31st of each year  
\* Date of priority of appropriation March 24, 1975

Description of works of diversion, manner and place of use:  
Water is diverted by means of a drilled well 535 feet deep, 12 inch casing, via a 60 HP Amarillo pump and a caterpillar 3305 motor, to a storage tank and thence conveyed by a distribution system to a gravel washing and crushing plant and a tailings pond located within the E 1/2 NE 1/4; S 1/2 of Section 15; portions of the SW 1/4 of Section 14; portions of the NW 1/4 and NE 1/4 of Section 23; portions of the NE 1/4 of Section 22, T.21N., R.20E., M.D.B.&M. Water is to be used for commercial (dust control - gravel pit operation) and domestic purposes.

This total combined duty of water under any certificates issued for Permits 48919 and 48920 shall not exceed 205.08 acre-feet annually.

\*This certificate changes the point of diversion, manner and place of use of Permit 47791, which changes the place of use of Permit 36056, which changes the point of diversion and place of use of Permit 29288, therefore, the date of priority remains the same as Permit 29288.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
