CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Richard W. Arden, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows: NW 1/4 NE 1/4 Section 22, T.23N., R.20E., M.D.B.&M., or at a point from which the NW corner of Section 15, T.23N., R.20E., M.D.B.&M., bears N. 32° 08' 11" W., a distance of 6,255.90 feet situated in Washoe County, State of Nevada.

Now KNOW YE. That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\*This certificate changes the place of use of Permit 40547 which changes the place of use of Permit 28275, therefore, the date of priority remains the same as Permit 28275.

The total combined diversion rate under this certificate and any certificate issued under Permit 49669 shall not exceed 2.5 cubic feet per second.

The total combined duty of water under this certificate and any certificate issued under Permit 49669 shall not exceed 535.4 acre-feet per annum.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
