CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Bruce L. Rice, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Chiatovich Creek

through a diversion box, headgate, pond, pump and irrigation system for Irrigation

purposes. The point of diversion of water from the source is as follows: NW 1/4 SW 1/4 Section 28, T.1S., R.35E., M.D.B.&M., or at a point from which the SW corner of said Section 28 bears S. 19° 56' W., a distance of 2,740.0 feet

situated in Esmeralda County, State of Nevada.

Now Know YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\*This certificate changes the place of use of a portion of Permit 23192, Certificate 7198, which changed the point of diversion of Permit 17177, therefore, the date of priority remains the same as Permit 17177.

This certificate is issued subject to the terms of the permit and with the understanding that the total combined duty of water under this certificate and any certificates issued under Permits 45520 and 45522 shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
