CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Alan S. Boyack, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source

through a drilled well, pump and distribution system for Irrigation

purposes. The point of diversion of water from the source is as follows: SW 1/4 SW 1/4 Section 34, T.35N., R.62E., M.D.B.&M., or at a point from which the SW corner of said Section 34 bears S. 89° 50' 00" W., a distance of 1,316.40 feet

situated in Elko County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\*This certificate changes the point of diversion of Permit 42990, which changed the point of diversion of a portion of Permit 30345, Certificate 9427, which changed the place of use of Permit 27137, therefore the date of priority remains the same as Permit 27137.

This certificate and any certificates issued under Permits 30345, 30350 and 48485 shall be limited to a total combined annual duty of 1211.60 acre-feet. This certificate and any certificate issued under Permit 48485 shall be limited to a total combined annual duty of 695.79 acre-feet.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 3.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
