CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Rual Meredith, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Darlene Spring through a diversion box and ditching system for Irrigation purposes. The point of diversion of water from the source is as follows: SW 1/4 NW 1/4 Section 3, T.21N., R.22E., M.D.B.&M. or at a point from which the NW corner of said Section 3 bears N. 18° 36' W., a distance of 2264.0 feet situated in Washoe County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation: 0.019 c.f.s but not to exceed 8.1 acre-feet per season
Period of use, from: April 1st to October 31st of each year
Date of priority of appropriation: January 14, 1981

Description of: land to which the water is appurtenant: 3.7 Acres in the SW 1/4 NW 1/4 Section 3, T.21N., R.22E., M.D.B.&M.

The total combined duty of water under any certificates issued for Permits 43103, 43104, 43105 and Proof 02333, Permit 11653, Certificate 3663, and Permit 11654, Certificate 3664, shall not exceed 375.18 acre-feet annually.

This Certificate is issued supplemental to any certificate issued under Permit 43105 and Proof 02333, Permit 11653, Certificate 3663, Permit 11654, Certificate 3664 and as tabulated below.

This Certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per season from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
